Minutes

Discussion Items

1. Invertebrate Proposal Status

- The proposal is set for a second reading with the County Commission on February 14, 2019. There were no objections at the first reading. The proposal has been approved by the City of Columbia as well as The University of Missouri (MU)
- The Request for Statement of Qualification (RSQ) was changed to be open for 45 days instead of the originally planned 60 days.

2. Stormwater BMPs and Map of BMPs (City of Columbia)
 - Tom Wellman (City of Columbia, Public Works) displayed GIS layers of some of the BMPs and stormwater infrastructure within 500 ft of Hinkson Creek.
 - Tom also described the process for development/redevelopment BMP requirements.
 - Boone County and the City of Columbia are looking at ways to combine their BMP and stormwater infrastructure data to supply to the Science Team.
 - Suggested to give tour of some of the more effective BMPs with in the City at one of the next field trips.
3. Update on Water Center Initiative (MU)
 - The University of Missouri gave an update on the Water Center Initiative. The University is looking to combine Engineering and CAFNR water groups to be more effective on projects and studies.
4. Hinkson Outdoor Lab
 - The University gave an update on a proposal to make Hinkson Creek an “Outdoor Laboratory” for research, education, and outreach within the community.
 - The University is looking for match funds for research projects and equipment.
 - Alba has sent out the proposal for review

 - i. Boone county is working on a four-part editorial on Hinkson Creek: 1)History; 2)What has Happened Since 303(d) Listing; 3)Where Are We Now; 4) Vision For Moving Forward
