1. **CALL TO ORDER** –The meeting was called to order at 9:07 am by Kori Thompson.
2. **APPROVAL OF AGENDA** –Agenda was approved.
3. **APPROVAL OF MINUTES FROM LAST MEETING** –May minutes were approved.
4. **AGENDA ITEMS**
  - **Infiltronics Stormwater Quality Treatment Device**
    - Dr. Kathleen Trauth and Virginia Trauth gave a short presentation on the Infiltronics Stormwater Quality Treatment Device. Information presented included a brief history of the company, the theory behind the design of the device, and a case study of the first installation with preliminary results. The presentation was followed by a short Q&A session.
