4. AGENDA ITEMS

a. El Chaparral Update

b. USDA RCPP Update

It sounds as if a new Farm Bill is a high priority for the federal legislature. No word on whether RCPP will be a part of the new bill, but we may learn something soon.

- iii. Boone County IT has been helping Lynn prepare a map of animal operations in order to help focus invitations.

The group discussed the need to make the event relevant and practical for farmers. The Farm Bureau would be a good partner if they are willing.

d. Next Steps

- i. Hinkson Woods- John Mehuys has been talking with Conservation Dept. about getting a 5 Star Grant to work on some restoration. There is drained pond that could be re-established as good amphibian habitat.
- ii. The upcoming Stakeholder tour may include some riparian sites we should be ready to present to them about what it takes to do restoration; prep work, invasive removal, available grants, etc.

iii. Mike Powell noted that quarry pits in the Hinkson Valley Greenbelt Trust property might be a good habitat restoration project. He noted that the Audubon Society has done a bird survey there and should have a bird list soon.
